Location: Troy Park Turf Fields, 6450 Mansion Ln, Elkridge, MD 21075

Notes about Troy Park:

- All fields are brand new artificial turf. WATER ONLY allowed inside the fencing of each field.
- No alcohol permitted
- Bathrooms and water fountains are available throughout the park
- Please DO NOT set up team tents on any artificial surfaces. There are several small grassy areas to set up team tents, as well as a large, undeveloped, grass field near the entrance of the park. No tents or team set-ups should be located on any artificial surfaces.
- Only teams that are playing should be inside the fencing of each field. All spectators should remain in the stands.

Kickoff: First set of matches kickoff at 9:00 a.m. PLEASE BE READY FOR THE COIN TOSS AT HALF-TIME OF THE GAME BEFORE YOUR GAME.

Check - In: Please have a representative from your team check in at the tournament directors pavilion (ask for Will Knipscher, Evan Harkum, or Brian Fitzpatrick) upon arrival. If you have not done so yet, please give us your payment and rosters. We will give you a case of water.

Parking: Parking is free!

Field information: Due to the nature of artificial turf sports fields, there are several colored lines on the field. The YELLOW lines are fresh and are for rugby. Please take note of all field lines before your first game. In addition, the try line is located in front of the posts at every field. Although we will have scoreboard operators, the official game clock and score are kept with the head referee each match.

Tournament Rules and Rostering: For Men’s and Women’s Premier, and Men’s Open, all MAC guidelines apply. For Men’s and Women’s social divisions, **please fill out and submit the attached roster form prior to your first game. ALL PLAYERS MUST BE CIPP ENROLLED WITH USA RUGBY**

Tournament PARTY: There will be a trophy presentation and post-tournament celebration following the tournament hosted at the Guinness Open Gate Brewery’s taproom, 5001 Washington Blvd, Halethorpe, MD 21227. All teams and guests are invited!

Pool Play and Playoffs

Women's Social (one pool, 4 teams)

- Each club will play 3 pool matches
- The top two finishers in pool play will play again for 1st place and the bottom two finishers will play again for 3rd place

Men's Open (three pools of 4 teams)

- MAC Guidelines supersede any discrepancies found in this information
- Each club will play 3 pool matches
- Each of the three pool winners and the highest ranking second place pool finisher (based on the pool play advancement list below) will move on to the cup semifinals with the second place finisher playing the highest ranked first place finisher. Finals and a 3rd place match will follow.
- The remaining two second place finishers will play a single match for 5th place
- The top two third place finishers will be able to play an optional single match for 7th place if both teams agree. If either team declines, the spot can be filled with lower seeds

Women's Premier and Men's Social (two pools of 3 teams each)

- MAC Guidelines supersede any discrepancies found in this information
- Each club will play 2 pool matches
- The top finisher in pool K/H will play the second place finisher in pool L/J, and the top finisher in pool L/J will play the second place finisher in pool K/H in the cup semifinal match. Finals and 3rd place matches will follow (optional for the Men's Social)
- The third place finisher in each pool will play each other in a single match for 5th place

Men's Premier (two pools of 4 teams each)

- MAC Guidelines supersede any discrepancies found in this information
- Each club will play 3 pool matches
- The top finisher in pool A will play the second place finisher in pool B, and the top finisher in pool B will play the second place finisher in pool A in the cup semifinal match. Finals and 3rd place match will follow.
- The third place finisher from each pool will play in 5th Place Match
- The fourth place finisher from each pool will play in 7th Place Match

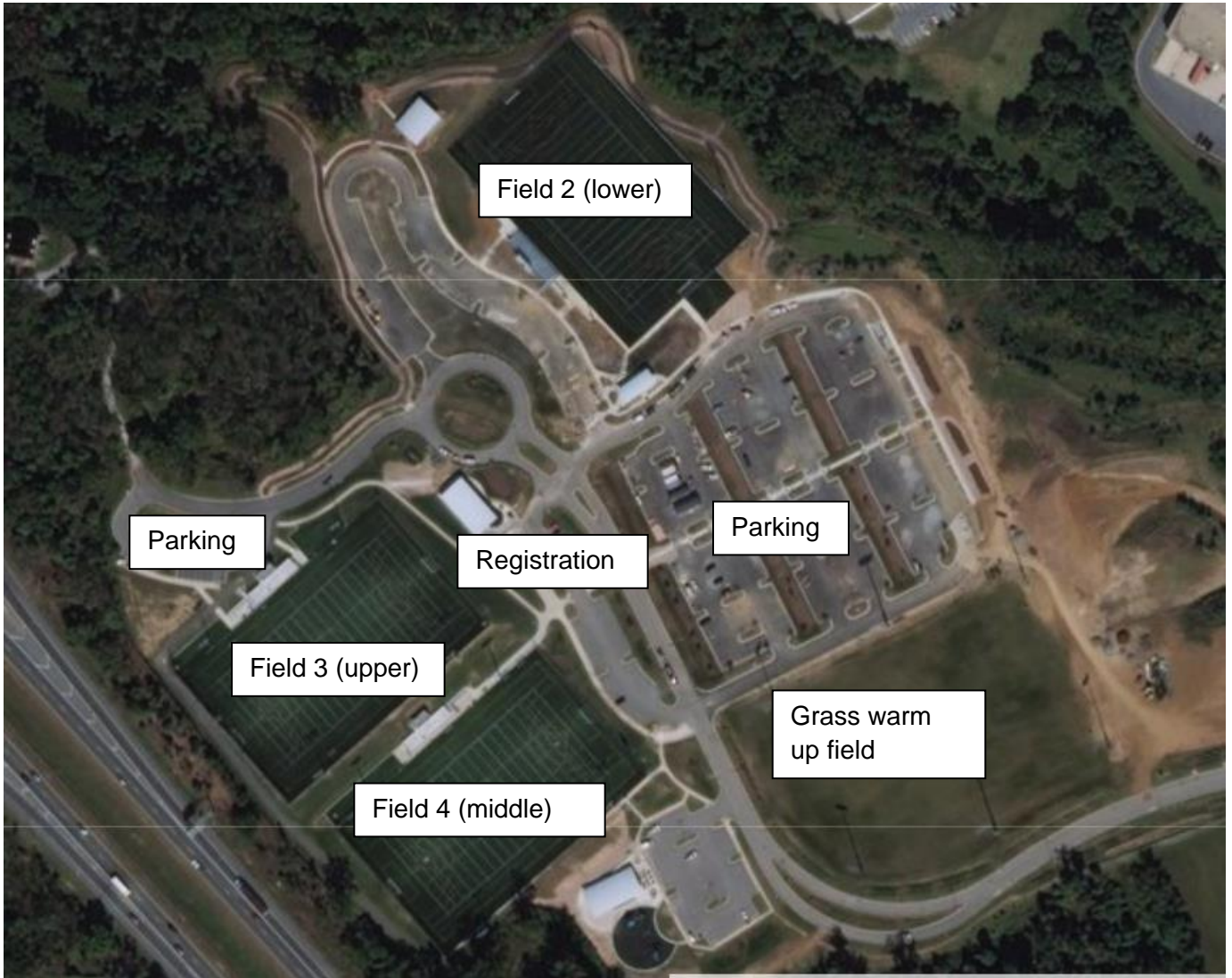
